The review of the multiagency training programme continues. On behalf of the sector, we have stressed that the demand for essential awareness is high. The LSCB recognise its importance and new dates for **Essential Awareness Training** can be expected imminently. #### **Allegations against Adults that Work With Children Training**

The role of the LADO is now well established within the sector. However, we are seeing reoccurring trends within Ofsted inspection reports that would indicate that practitioners are still not confident of the procedure to follow when an allegation is made against a member of staff.

Instinctively providers want to address such issues as soon as possible, but by failing to contact the LADO as the initial step, they are failing to follow the procedures set out the in the LSCB online policies and procedures and are thereby not meeting the statutory requirements of the EYFS.

To ensure that you and your team are up to date with your knowledge and understanding of what to do, should an allegation be made against a member of staff, the following training will be going live on the Children's Workforce Matters website shortly;

Every two months the Multi Agency Safeguarding Frontline Practitioners Group meet. This meeting is run by the Leicester Safeguarding Children Board and brings together a representative from all local authority services such as Schools, the Police, Health, Early Help etc. The aim of the meeting is to share practice issues, some will be dealt with at the meeting, and others may be escalated and signposted to the relevant department. Our team (EEDT) have representation at this meeting and are able to share any challenges you may have around child protection issues, this may be when making a referral or with existing children that are subject to a multi-agency plan.




#### What is this website about?

## The Prevent duty

Departmental advice for schools and childcare providers

#### **The Prevent Duty**

Reference to The Prevent Duty continues to be a trend in recent Ofsted inspection reports. Whilst the sector endeavours to understand and embed Prevent within their practice, it is apparent that staff can still find it difficult to articulate their knowledge of the signs and indicators of radicalisation, contributing factors and how they support children in developing resilience to becoming radicalised.

It may therefore be advisable to invest some time in reviewing staffs knowledge and understanding of Prevent and identifying any areas for improvement.

At the last series of Quality Forums, we spent some time on tables mind mapping everything we knew and understood about Prevent and what some questions we still feel we are unable to answer. This was not only an opportunity to learn from one another, but also highlighted meaningful next steps for practitioners to go away with to build on their practice. Consider bringing this activity to your next team meeting. Encourage staff to share their expertise and develop confidence in articulating their knowledge.
